



## Confirmation of RoHS-Conformity to Legislation 2011/65/EU and recast of Directive 2015/863/EU

Dear Sir or Madam,

We hereby confirm that the products manufactured by MTC are corresponding to the guidelines of the RoHS directive (2011/65/EU) and the above mentioned recast (2015/863/EU). Based on the mentioned legislation they are free of:

- Lead (0,1 %)
- Mercury (0,1 %)
- Cadmium (0,01 %)
- Hexavalent chromium (0,1 %)
- Polybrominated biphenyls (PBB) (0,1 %)
- Polybrominated diphenyl ethers (PBDE) (0,1 %)
- Bis(2-ethylhexyl) phthalate (DEHP) (0,1 %)
- Butyl benzyl phthalate (BBP) (0,1 %)
- Dibutyl phthalate (DBP) (0,1 %)
- Diisobutyl phthalate (DIBP) (0,1 %)

All our suppliers of raw materials and semi-finished goods provided us with confirmations that their products are tested either by themselves or by authorized laboratories. All materials supplied to us are free of the above mentioned chemicals. Therefore they correspond to the guidelines of the RoHS directive as well.

MTC offers SMD fasteners (article designation beginning with "SMF-...") made of metal alloys containing lead. Usually those are brass (material: 2.0401; CuZn39Pb3) or carbon steel (material: 1.0718; 11SMnPb30) containing more than 0.1 mass% lead (CAS: 7439-92-1) but remain below the threshold of applicable exemptions.

In order to ensure compliance with the regulation, we regularly assign an independent laboratory to test our products for the presence of all listed substances. The latest test was performed on 27.02.2024 and confirmed compliance.
